## VeeVo Vault 22R3 Release Impact Assessment

The Release Impact Assessment (RIA) documents the new capabilities introduced in Vault in 22R3 that may affect a customer's Vault. We release a version of the RIA in advance of the general release. The Validation Impact Assessment, which contains validation information for new features that have validation impact in 22R3, will be available in the Veeva Compliance Docs (VeevaDocs) Vault on October 31st. Name of the feature introduced in 22R3
GxP risk analysis takes into account data integrity, security, and confidentiality assuming the feature is turned on (either automatically or via configuration). Veeva performs validation testing on all High and Medium GxP risk items.
